Please amend Document B1 to 3 years instead of 10	Document B1 shall be changed in accordance with clause 1.10 such that the warranty period for the electro-mechanical systems shall not be less than 3 years.
14	Appendix C item 1.013	What are the dimensions of the required printed material on the membrane?	The dimensions are a function of the size of the membrane and the content being printed. Please .provide a price quote per sq.m
